Due to **COVID-19**, maintenance was not able to complete all furnace filter changes. The remainder will be done the end of April.

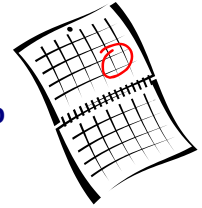
