Snow Removal

Maintenance will begin plowing at 5:30 am if we receive <u>3 inches of snow or more.</u> Please be extra cautious around the snow plows.

Just because you see them doesn't mean they see you.

<u>Don't expect immediate results</u> <u>during times of heavy snowfall (6"</u> <u>or more). Be patient and don't call</u> the office!

Mold Reminder

Mold can be a serious problem and cause harm to you and your family.

You can get rid of mold by spraying the areas with Lysol, white vinegar or a solution of 1 teaspoon baking soda combined with 2 cups water. Let it dry naturally. You can also use any over the counter mold/mildew cleaner. Do not use bleach.

Are Your Windows Closed?

To ensure the heat stays in your unit, check to make sure your windows are closed and locked. A reminder to <u>Windsong Terrace</u> tenants who do not have electric heat...<u>DO NOT</u> turn your heat down when you leave your house. Your heat is generated from a boiler system which takes several hours to bring the temperature back up after being turned down.

<u>HEAP</u>—If you pay your own heat, you may be eligible for HEAP assistance. If you receive food stamps or social security, you most likely qualify for HEAP assistance. Call Wayne County Department of Social Services at (315) 946-4881 for more information.



Northview & Windsong Terrace Tenants...

Do not place electrical appliances such as TV's and electric heaters near your thermostat or block your thermostat with large furniture. These items trick the thermostat into thinking the temperature of the room is different than what it really is, not allowing your heater to work properly.

NHA Reporting Requirements...

Recently there has been some confusion as to what needs to be reported to the Newark Housing Authority office and when it needs to be reported. Here's what you need to know:

- * ALL changes in household composition MUST be reported immediately. If a member of your household moves out, you must let the office know at the time that they move out. If you would like to add somebody to your household, you must come in to the office and obtain the required paperwork <u>prior</u> to adding them. If the person is age 18 or over, they will need to go through the application process <u>prior</u> to being added.
- * ALL changes in income (high school/college students' employment; all Social Security, SSI, and/or SSP—including children's; reimbursement of Medicare; public assistance; unemployment; any raises, increase/decrease in hours, job changes; child support payments/changes in court order; changes in child care expenses; any other money coming into your household including assistance from family/friends paying for utilities or other household goods) MUST be reported in writing within 10 days.

If you have any further questions regarding this, feel free to contact the office. We will be happy to answer any questions you may have.

If you are having a problem with leaky faucets or running toilets, please advise the office ASAP so that we can fix the problem quickly.

If you suspect a leak, one way you can check is to make sure all faucets are off in your house and look at your water meter. If it is turning, you probably have a leak and should contact the office immediately.

Don't let your money go down the drain.
