Kiddy Pools

- Newark Village Code only allows for small swimming pools no more than 24 inches deep—this means the pool cannot hold more than 24 inches of water.
- Due to electrical hazards, no pool filters will be allowed!! *
- Move your pool to different spots in your yard to keep the grass looking fresh and green and prevent you from being charged for reseeding.
- All pools must be put away by September 30th. Any pools remaining * after September 30th will be removed by NHA maintenance staff.

Reminder to Pet Owners:

Per NHA Pet Policy, Page 2, Section 9: "All pets shall be registered when acquired and when requested by NHA. Registering requires proof of current dog license, up to date vaccinations, identification tag, verification of spaying/ neutering and written proof of satisfactory annual medical checkup by a licensed veterinarian."

Please be reminded that this documentation will be required at <u>every</u> annual recertification as long as you own the pet.
