Plumbing Care

Never pour cooking oil or other greasy materials down the drains. Oils and grease used in cooking may be liquid after use, but they can harden inside pipes and cause blockages. Instead of pouring grease down the drain, wipe it off the pot or pan with a paper towel, place a slice of bread in it to soak the grease up and throw it away or pour cooled oil and fats into a non-recyclable container and then dispose with the trash.

Avoid putting feminine products and baby wipes down the toilet. They will not only plug your toilet but also plug the sewer line.

Please make your family aware of what should and should not be put down the drain. If maintenance finds the clog is due to tenant neglect, you will be charged.

Reminder to dog owners...

Please remember that your signed Pet Policy states on Page 2 (14)..."
The tenant shall have pets restrained so that maintenance can be performed in the unit. The tenant shall, whenever an inspection or maintenance is scheduled, either be at home or shall have all animals restrained or caged. "You may know that your pet is friendly but our maintenance staff does not, and they will not enter a unit to perform a work order or an inspection if the animal is not restrained. Be aware...if maintenance enters your unit to perform a work order or an inspection and are unable due to an

work order or an inspection and are unable due to an unrestrained animal, you will be charged \$25.00. If the same situation occurs again, a Warning Letter will be issued as well.
